

Sir,

With reference to the above, the observations of this Department are noted below:-

“Proposal regarding refund of KB Assistance credited after the death of the beneficiaries or to Ineligible beneficiaries has been examined. Instant proposal is related to modalities of refund of amount of Wrong Credit/Duplicate payment/Other ineligible payments to KB(AI) Beneficiaries.

ADA of Blocks may please pass on the information to DDA(ADMN) of the District. They may in turn inform DAWB/SNO the details of such inadmissible payments. On receiving this information, WBSCBL may be informed by DAWB to reverse credit of these amounts to Account of MD, WBSSCL without any charge for such refund. Respective banks may be informed by the ADAs to share transfer reference number to existing bank account at WBSCBL for tracking.

The amount so recovered may be deposited to Government exchequer by cheque/any other acceptable instrument under the prescribed H-O-A as stated above.

Concerned ADA of the concerned block and chairman of BLEMC may be requested to monitor the disbursement closely and take necessary steps immediately for recovering any ineligible and wrong credit in accordance with above stated modalities.


Concerned ADAs may be required to submit report mandatorily in the suggested pro-forma to DAWB & EoS with the countersignature of DDA(ADMN) after refund of assistance of KB (AI) for monitoring.




